


Project Location

- 2660 2nd Avenue
- City-owned, full-block site occupied by a decommissioned MTA bus depot
- A portion of the site is the historic Harlem African Burial Ground (HABG)








History

The Harlem African Burial Ground dates to Harlem's earliest days

- 1660: Nieuw Haarlem is chartered by the Dutch on indigenous land with Low Dutch Reformed Church as founding church
- 1869: Prompted by northward expansion of the city, church leaders begin transferring human remains of white
 Europeans to new plots. Those buried in the HABG are left behind




History

Several uses occupied the site of the Harlem African Burial Ground


- 1885-1917: Beer garden and casino
- 1917-1918: 15th New York National Guard Infantry Regiment barracks
- 1918-1945: Movie studios
- 1945-1962: Third Avenue Railway Company trolley barn; Current depot built in 1947
- 1962-2015: MTA/NYCT 126th St bus depot





Historical Records

- Through research into their records, Elmendorf Reformed Church has identified over 40 names of those buried at the Harlem African Burial Ground
- One example is Phoebe Tamar she and at least 7 other members of her family are known to have been buried at the Harlem African Burial Ground

Project Background

- 2015: MTA decommissions bus depot and vacates site
- 2015-2016: NYCEDC is asked to lead the redevelopment project and commissions a first-phase archaeological investigation, which uncovers over 140 human remains on the site
- 2017: CB11, Manhattan Borough President, City Planning Commission, and City Council approve land use actions to facilitate the redevelopment project
- 2023: Bus depot transferred to City ownership

Project Goals

- From 2015-16, the Bus Depot Task Force a group of elected officials, City agencies, and community stakeholders, including the HABGTF – convened to develop goals for a future mixed-use project.
- After this community-led planning process, the project was approved through the ULURP process in 2017 with support from Community Board 11, and the goals developed were memorialized in a Points of Agreement Letter

Project Goals

- The project goals are to:
 - Honor and memorialize the Harlem African Burial Ground with a public outdoor memorial on the entire historic footprint of the burial ground and an indoor cultural education center
 - Address affordable housing and job creation needs in East Harlem on the remainder of the site through a mixed-use program including roughly 600-700 units of housing, of which at least 80% will be affordable, commercial space and additional community space

Moving the Project Forward

- NYCEDC and the Harlem African Burial Ground Initiative announced next steps on August 15th, which are:
 - A new phase of **archaeological work**
 - An RFP for an education & engagement effort
- Currently executing a Social Media Campaign, including LinkNYC ads, to support the announcement and these next steps

Education & Engagement RFP

- Open RFP for a multi-strategy, widereaching education and engagement effort in coordination with the HABGI to increase awareness and understanding of the Harlem African Burial Ground, its history, and the archaeological work
- Scope includes stakeholder mapping, development of an education and engagement plan, execution of public events and creation of a public report
- Submissions due October 4th, 2023



- Inventory any recovered human remains/artifacts



2015 Archaeological Investigation – Collaboration

Descendant Community - Per LPC Guidelines

- "A good faith effort must be made to identify the appropriate descendant entity. This may include a biological relative or a responsible entity such as a religious organization or successor organization (in the case of a former graveyard). The entity(ies) should be consulted about disposition and treatment of the human remains"
- May include a biological relative or a responsible entity, such as a religious organization or successor organization in the case of a former graveyard, that should be consulted for any actions that may impact burial grounds or sites with great religious or cultural significance.

2015 Archaeological Investigation – Methods

- Collaboration on Work Plan with HABG Task Force and Descendant Community
- Removal of slab in four test locations
- Mechanized and by hand soil removal
- Soil Screening
- Documentation
- Public Participation








2015 Archaeological Investigation – Results

- No human remains within original cemetery footprint
- Soils containing burials likely removed when a hill was leveled in the 1850s



2015 Archaeological Investigation – Results

- Human remains recovered in fill material outside cemetery boundaries
- Additional human remains are present extending into the walls of Trench 2



2015 Archaeological Investigation – Results

- Human remains were fragmentary
- Preservation was poor
- Minimum number of individuals = 2
- One nearly complete cranium recovered
 - Likely an adult female
 - Likely of African descent


Primary Tasks

- 1. Planning/Consulting
- 2. Fieldwork

2023/2024 Archaeological Excavation – Goals

- On site collaboration with HABGI and descendant community
- Ensure respectful treatment of human remains at all times
- Determine horizontal and vertical extent of human remains on site
- Document and recover human remains and associated funerary materials
- Assess potential for additional human remains in depot
- Assess potential for additional human remains outside of depot
- Inventory, analyze, and stabilize recovered human remains for later reburial


2023/2024 Archaeological Excavation – Methods

- Planning/Consulting
 - Collaboration on Work Plan with HABGI and descendant community
 - Project description
 - Historic context
 - Research design
 - Field protocols
 - Management
 - Public involvement
 - Planning and logistics with Armand
 - Agency Consultation: NYCLPC, NY State (SHPO), Advisory Council
 - HABG is listed on the National Register of Historic Places

2023/2024 Archaeological Excavation

Anticipated Field Methods

- Removal of rebar-reinforced concrete slab
- 2. Systematic testing across interior
- 3. Delineate extent of area of sensitivity
- 4. Expose, document, and recover



2023/2024 Archaeological Excavation

Post-fieldwork next steps

- Plan for ceremonies to commemorate and honor those buried at the HABG
- Completion of fieldwork;
- Further consultation with the HABGI and descendant community regarding analysis
- Draft and Finalize Technical Report
