CERTIFICATE OF INCORPORATION

OF

UNDER SECTION 402 OF THE

NOT-FOR-PROFIT CORPORATION LAW OF THE STATE OF NEW YORK

THE UNDERSIGNED INCORPORATOR, being a natural person of at least 18 years of age, for the purpose of forming a not-for-profit corporation pursuant to Section 402 of the Not-for-Profit Corporation Law of the State of New York (the "N-PCL"), does hereby certify as follows:

FIRST: The name of the corporation is NYC Neighborhood Capital Corporation (the "Corporation").

SECOND: The Corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the N-PCL. The Corporation is a charitable corporation under Section 201 of the N-PCL.

THIRD: The purposes of the Corporation shall be any and all purposes for which corporations may be organized under the N-PCL as a charitable corporation.

FOURTH: The Corporation shall have all powers now and hereafter granted to a corporation under the N-PCL.

FIFTH: The Corporation is not formed to engage in any activity or for any purpose requiring approval or consent from, or notice to, any State of New York official, department, board, agency or other body. No such approval, consent or notice is required to form the Corporation.

SIXTH: The office of the Corporation shall be located in the County of New York, City of New York, State of New York.

SEVENTH: The Corporation shall have a single class of members. The number, tenure and other matters in respect of members, and the procedure for appointing members, shall be set forth in the By-Laws of the Corporation.

EIGHTH: The Corporation shall be managed by a board of directors, which shall, prior to the adoption of the By-Laws of the Corporation, be comprised of those persons named in Paragraph NINTH hereof. The number, tenure and other matters in respect of the board of directors shall be set forth in the By-Laws of the Corporation.

TENTH: The Secretary of State of the State of New York (the "Secretary") is hereby designated as agent of the Corporation upon whom process against it may be served. The post office address to which the Secretary shall mail a copy of any process against the Corporation served upon the Secretary is c/o New York City Economic Development Corporation, 110 William Street, New York, New York 10038, Attention: General Counsel.

ELEVENTH: Notwithstanding any other provision hereof to the contrary, the Corporation is organized exclusively for charitable purposes, as described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or corresponding provisions of any subsequent federal tax laws, and the Corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from federal income tax under section 501(c)(3) of the Code, or the corresponding section of any subsequent federal tax laws, or (b) a corporation, contributions to which are deductible under section 170(c)(2) of the Code, or the corresponding section of any subsequent federal tax laws.

INDESCRIPTION OF THE PROPERTY OF THE PROPERTY

TWELFTH: No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.

THIRTEENTH: No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, trustees, directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the Corporation's purposes set forth in Paragraph THIRD hereof.

FOURTEENTH: In the event of the liquidation, dissolution or winding up of the affairs of the Corporation, whether voluntary, involuntary or by operation of law, no member, director, officer or other private person, corporate or individual, or other private interest, is entitled to any distribution or division of the Corporation's remaining funds and other assets. The Corporation, after the payment of all of its debts and liabilities of whatsoever kind and nature (including the payment of loans and contributions), shall distribute the balance of its assets to the City of New York for a public purpose that is an exempt purpose under Section 501(c)(3) of the Code, or the corresponding section of any subsequent federal tax laws.

FIFTEENTH: In any taxable year in which the Corporation is a private foundation as defined in Section 509(a) of the Code, the Corporation shall distribute its income for said period at such time and in such manner as not to subject it to tax under Section 4942 of the Code, and the Corporation shall not (a) engage in any act or self-dealing which is subject to tax under Section 4941 of the Code, (b) retain any excess business holdings which are subject to tax under Section 4943 of the Code, (c) make any investments in such manner as to subject the Corporation to tax under Section 4944 of the Code or (d) make any taxable expenditures which are subject to tax under Section 4945 of the Code.
